Plan Design

- **Schedule of benefits** (each covered procedure code has a specific maximum benefit)
- **Missing tooth exclusion** (applies to teeth missing prior to effective date of coverage)
- **10-year crown rule** (replacement limitation per tooth)
- **12-month wait on specific services** (see handbook)
- **\$50 deductible applies to non-contracted providers only** (waived for class 1 services)
- **Two cleanings per year**
- **Perio maintenance limited to 4 per policy year**
- **Dependent age limit of 23**
